Whereas, the Henrico County Sheriff's Office ("HCSO") and MAO Pharmacy, Inc. ("Contractor") entered into Contract No. 2222A (the "Contract") dated November 5, 2021 to provide pharmaceutical and related services when needed and requested by HCSO; and,

Whereas, the original Contract term was from November 15, 2021 to December 31, 2023; and,

Whereas, the parties renewed the Contract for an additional one-year term ending December 31, 2024; and,

Whereas, the parties renewed the Contract for an additional one-year term ending December 31, 2025; and,

Whereas, the parties wish to add amend the contract to better define the existing hourly rate and add an additional hourly rate required to provide pharmaceutical services required for assistance in drug reconciliations, receipts, distribution and assembling of kits for controlled substances and narcotics for first responders.

Now, therefore, the parties agree to amend the Contract as follows:

1. The Contractor shall provide pharmaceutical services required for assistance in drug reconciliations, receipts, distribution and assembling of kits for controlled substances and narcotics for first responders ("First Responder Kit Services"), if and when needed.

2. Table 1 of the Contract shall be revised to read as follows:

Non-mass Vaccination Clinic Services	\$40.00 per shot + vaccine cost
Supervision by an Onsite Pharmacist	\$150.00 per hour per pharmacist
Regular hourly rate (9:00 a.m. – 5:00 p.m., Monday through Friday) for First Responder Kit Services	\$150.00 per hour
Extended hourly rate (all hours outside of Regular hourly rate) for First Responder Kit Services	\$300.00 per hour

3. All other provisions of the Contract remain in full force and effect.
