Ladies/Gentlemen,

Please make the following corrections, deletions and/or additions to the above referenced IFB:

Due Date and Requirements Changes

1. The bid due date is being moved to July 22, 2022 at 2:00 PM.
2. The specifications for Trousers in Lot A - Section I, Item E (1) shall be changed to read:

Men's Command Dress Trousers by Flying Cross by Fechheimer Item: 37291: Fabric Content: Burlington Raeford 55% Polyester/45% Wool; Weight: 13 - 13 ½ oz. per linear yard; Weave: Serge; Color: LAPD Navy Blue, and Freedom-flex waistband system. A 1 ¼" wide stripe made from the same French Blue fabric as the specified shirts shall be top stitched from the bottom side of the waist band to the bottom hem of the trouser. Striping shall be placed on the back panel of the trouser on each side leg.

3. The specifications for Trousers in Lot A - Section I, Item E (2) shall be changed to read:

Women's Command Dress Trousers by Flying Cross by Fechheimer Item: 37291w: Fabric Content: Burlington Raeford 55% Polyester/45% Wool; Weight: 13 - 13 ½ oz. per linear yard; Weave: Serge; Color: LAPD Navy Blue, and Freedom-flex waistband system. A 1 ¼" wide stripe made from the same French Blue fabric as the specified shirts shall be top stitched from the bottom side of the waist band to the bottom hem of the trouser. Striping shall be placed on the back panel of the trouser on each side leg.

4. The specifications for Trousers in Lot A - Section I, Item E (3) shall be changed to read:

Men's Class A/B Dress Trousers by Flying Cross by Fechheimer Item: 47280: Fabric Content: Burlington Raeford 75% Polyester/25% Wool; Weight: 12 oz. per linear yard; Weave: Serge; Color: LAPD Navy Blue, and Freedom-flex waistband system. A 1 ¼" wide stripe made from the same French Blue fabric as the specified shirts shall be top stitched from the bottom side of the waist band to the bottom hem of the trouser. Striping shall be placed on the back panel of the trouser on each side leg.

5. The specifications for Trousers in Lot A - Section I, Item E (4) shall be changed to read:

Women's Class A/B Dress Trousers by Flying Cross by Fechheimer Item: 47280: Fabric Content: Burlington Raeford 75% Polyester/25% Wool; Weight: 12 oz. per linear yard; Weave: Serge; Color: LAPD Navy Blue, and Freedom-flex waistband system. A 1 ¼" wide stripe made from the same French Blue fabric as the specified shirts shall be top stitched from the bottom side of the waist band to the bottom hem of the trouser. Striping shall be placed on the back panel of the trouser on each side leg.

6. Lot D, Item 1 shall be changed to read:

Boston Leather 1-3/4 inch garrison belt, mfg.# 6605 or approved equal, black in color, plain finish with the option of a gold or silver buckle. Pricing shall be inclusive of sizes 26 to 36.

7. Item 12 shall be added to Lot D with the following specifications:

Boston Leather 1-3/4 inch garrison belt, mfg.# 6605 or approved equal, black in color, plain finish with the option of a gold or silver buckle. Pricing shall be inclusive of sizes 37 to 48.
