This Goods Contract (this “Contract”) entered into this 1st day of April 2023, by the County of Henrico, Virginia (the “County”) and Strohman Enterprise, Inc., a Commonwealth of Virginia corporation, and its successors it assigns (the “Contractor”).

SCOPE OF CONTRACT: The Contractor shall furnish all materials, equipment, and labor necessary to provide Safariland Vest Carriers and Accessories to the County as set forth in the Contract Documents.

COMPENSATION: The compensation the County will pay to the Contractor under this Contract shall be in accordance with Appendix A.

CONTRACT TERM: The Contract term shall be for a period of one year beginning April 1, 2023 and ending March 31, 2024. The County may renew the Contract for up to four one-year terms giving 30 days’ written notice before the end of the term unless Contractor has given the County written notice that it does not wish to renew at least 90 days before the end of the term.

CONTRACT DOCUMENTS: This Contract hereby incorporates by reference the documents listed below (the “Contract Documents”) which shall control in the following descending order:

1. This Goods Contract between the County and Contractor.
2. Invitation for Bid No. 23-2502-3JEC, dated March 3, 2023 (as modified by any addenda).
3. The Contractor’s bid dated March 9, 2023.
