

COMMONWEALTH OF VIRGINIA County of Henrico

Fire Suppression Systems Inspection, Maintenance, and Repair Services – Lot No. 2 Contract No. 2314B Amendment No. 1 April 17, 2024

Whereas, the County of Henrico, Virginia and County School Board of Henrico County, Virginia (collectively, the "County") and Fire & Life Safety America, Inc. (the "Original Contractor") entered into Contract No. 2314B (the "Contract") dated April 26, 2022, to provide Fire Suppression Systems Inspection, Maintenance, and Repair Services – Lot No. 2 when needed and requested by the County; and,

Whereas, the original Contract term was from May 1, 2022, to April 30, 2023; and,

Whereas, effective September 12, 2022, the Original Contractor assigned the Contract to Summit Fire & Security LLC, a Delaware limited liability company (the "Successor Contractor"); and,

Whereas, the Successor Contractor represents and warrants to the County that it alone has assumed all the Original Contractor's rights, obligations, and liabilities under and arising out of the Contract and is willing and able to perform the Contract; and,

Whereas, the Contract was renewed for an additional 1-year term beginning May 1, 2023, and ending April 30, 2024; and,

Whereas, the Successor Contractor and the County wish to renew the Contract for an additional one-year term beginning May 1, 2024 and ending April 30, 2025.

Now, therefore, the parties agree to amend the Contract as follows:

- 1. The Contract is hereby renewed for an additional one-year term beginning May 1, 2024 and ending April 30, 2025 at a 3% increase in Contract pricing, which is shown in Exhibit A attached hereto and incorporated herein by reference.
- 2. "Summit Fire & Security LLC, a Delaware limited liability company" shall replace "Fire & Life Safety America, Inc." throughout the Contract.
- 3. All other provisions of the Contract remain in full force and effect.
