## PRICE SCHEDULE – CONTRACT NO. 2194A

#### Engineered Wood Fiber Playground Mulch - \$19.13 per cubic yard

- A. General Requirements.
  - 1. Bid pricing shall be per cubic yard and shall include any and all costs associated with the delivery and handling of the product.
  - 2. Bid product shall remain the property of the Successful Bidder until a physical inspection is made or actual usage of the products and thereafter accepted to the satisfaction of the County or HCPS.
  - 3. Bid products shall be of the highest quality and comply with all terms and specifications contained in this Bid.
  - 4. In the event the Bid product supplied to the County or HCPS is found to be defective or not to conform to specifications, the County and HCPS reserve the right to cancel the contract upon written notice to the Successful Bidder and return products to Successful Bidder at the Successful Bidder's expense.
  - 5. Any damage to existing utilities, equipment or finished surfaces resulting from the performance of this Contract shall be repaired to the County or HCPS' satisfaction at the Successful Bidder's expense.
- B. Specifications.

The Successful Bidder shall deliver engineered wood fiber playground mulch that meets surfacing standards for CPSI or an approved equivalent that meets the requirement of ASTM F1292-13 Impact Attenuation of Surface, ASTM F2075-15 Compliant Engineered Wood Fiber and the International Play Equipment Manufacturers Association (IPEMA) certifications. Bidders shall provide proof of these requirements with their Bid Form.

- C. Delivery Requirements.
  - 1. Successful Bidder shall provide bid product to the County or HCPS within 10 calendar days of receipt of Purchase Order.
  - 2. The Successful Bidder shall coordinate with County or HCPS representatives, the delivery date, time and off-loading of the engineered wood fiber playground mulch.
  - 3. Successful Bidder shall deliver a minimum of 40 cubic yards of engineered wood fiber playground mulch to the designated drop off location at the schools listed on Attachment E.
  - 4. Successful Bidder shall deliver engineered wood fiber playground mulch as needed to the designated drop off location at various parks in Henrico County listed on Attachment F.
- D. Invoicing Requirements.

The Successful Bidder shall submit an itemized invoice including the contract number, purchase order number as supplied by the County or HCPS, order number, the total quantity purchased, unit cost per cubic yard, and total cost per location.
