- 1. Only new manufactured products shall be accepted. No irregular, imperfect or second-hand garments will be accepted.
- 2. Bidders must bid on all bid items to be considered for award. Failure to do so shall cause your bid to be deemed non-responsive.

- 3. The Division of Fire reserves the right to inspect all garments to ensure the condition of the apparel is free from defects. The Division of Fire shall reserve the right to reject any garment(s) at their discretion, declared to be flawed, defective or produced in error.
- 4. Unit prices shall be inclusive of any and all alterations required by the Division of Fire.
- 5. The Successful Bidder shall maintain a physical store in the City of Richmond, Henrico County, Chesterfield County or Hanover County. Stores shall be open during normal business hours Monday through Friday.
- 6. Bidders bidding other than as specified shall submit with their bid, product specifications and pictorial literature indicating that the product bid complies with specifications.
- 7. Low Bidder(s) bidding other than as specified will be contacted by Henrico County to provide one of each proposed equal bid item for inspection by the Division of Fire. The Division of Fire's approval or disapproval of a proposed equal shall be final.
- 8. Failure to provide the required information with your Bid and/or samples when requested may cause your Bid to be declared non-responsive.
- B. Specific Uniform Requirements.
 - 1. Button-Up Uniform Shirts

The Successful Bidder's price must include sewing Henrico Fire patches onto both sleeves. Patches will be provided by Henrico County.

- 2. Uniform Pants, Nomex
 - a. The Successful Bidder shall provide the County one un-hemmed set of pants in each waist size, and in each cut style (i.e. "regular" and full cut") that may be applicable, for each sex, to assist the Division of Fire in obtaining sizing information.
 - b. The Successful Bidder shall provide training to the Division of Fire staff on how to measure and record the inseam/hem length for uniform pants at no additional charge.
 - c. Division of Fire personnel will record the waist size for each firefighter, and also measure and record the hem length for each firefighter.
 - d. The Successful Bidder shall provide professional hemming of all pants at no extra charge. Stitching shall be done in accordance with the garment manufacturer's recommendations.
 - e. Pickup and delivery of the pants from the Successful Bidder's store to the Division of Fire warehouse will be performed by the County.
 - f. Bidders may provide an option for adding a 3-1/4" wide by 5" tall utility pocket on the right thigh of the uniform pant to include split pen pocket. Construction of the pocket must be the same color and material as the pants. List price per pocket on the Unit Price Bid Sheet Price Schedule. Optional utility pocket alteration shall not be part of the award.
- 3. Dress Uniforms.
 - a. Unit prices shall include professional measuring, tailoring and alterations for dress pants and dress blouses. All measuring and alterations shall take place at the Successful Bidder's store on an appointment basis during normal work hours.
 - b. Pickup and delivery of dress uniform items from the Successful Bidder's store to the Division of Fire warehouse will be performed by the County.
 - c. Dress blouses will include silver buttons for firefighters and gold buttons for officers at no additional cost.

- d. Successful Bidder shall provide appropriate piping and Maltese crosses which shall be sewn or embroidered on the dress blouse sleeves according to the Division of Fire's specifications.

Whereas, the County of Henrico, Virginia (the "County") and Witmer Public Safety Group, Inc. ("Contractor") entered into Contract No. 2217A (the "Contract") dated November 1, 2021 to provide Firefighter Uniforms and Accessories when needed and requested by the County; and

Whereas, the original Contract term was from November 1, 2021 to October 31, 2022; and

Whereas, by renewal letter dated September 29, 2022, Contractor agreed to renew the Contract for an additional one-year term beginning November 1, 2022 and ending October 31, 2023 at then new Contract pricing; and

Whereas, by Amendment 1 dated July 31, 2023, Contractor agreed to renew the Contract for an additional one-year term beginning November 1, 2023 and ending October 31, 2024 at then new Contract pricing; and

Whereas, by email dated September 18, 2024, Contractor has requested a 3% increase on items in Lot 1 and Lot 3 and a 5% increase on items in Lot 2; and

Whereas, the parties wish to renew the Contract for an additional one-year term beginning November 1, 2024 and ending October 31, 2025 at new Contract pricing.
