A. General Requirements.

- 4. Successful Bidder shall provide on-site sizing, repair and maintenance services within 7 calendar days of notification by the Police Division at no additional charge.
- 5. Successful Bidder shall provide replacement Uniform Shirt Carriers that are damaged or deemed unacceptable by the Division of Police within 15 days of notification at no additional charge.
- 6. All warranties either expressed or implied which are inherent in products specified shall be applicable to products furnished as the result of this solicitation, when bids are submitted. All products must have a standard manufacturer's warranty.
